4.	Fire Safety Undertaking, the school shall submit a Fire Safety Certificate in the prescribed format (APPENDIX - XII) of Circular No. 12/2022 dated 14.10.2022 available on the Board s website or as issued by a Competent Govt. Authority.
5.	Safe Drinking Water and Sanitation Certificate as per the format (APPENDIX - XIII) of Circular No. 12/2022 dated 14.10.2022 available on the Board s website.

B. The school shall ensure the availability of the following infrastructure & facilities in the schools within 02 years of grant of affiliation :-

1. Ramps at the entrance(s) as well as Ramps lifts for CWSN, to access the upper floors of the school (in case of a multistoried school) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
2. Separate toilets for CWSN, boys and girls and these should be provided on every floor (in case of multistoried schools) (Circular No. CBSE/AFF-05/2023 dated 06.03.2023).
